

DEED OF AMENDMENT

THIS DEED OF AMENDMENT TO THE TRUST, executed at Chennai, on this 22<sup>nd</sup> day of April, 2016 by **P. VISHNUCHARAN**, son of E. Panneerselvam, aged about 35 years, residing at No.10 (Old No.28), 12<sup>th</sup> Street, R-Block, Anna Nagar, Chennai – 600 040, hereinafter referred to as the Managing Trustee of the Trust.

WHEREAS vide a Deed of Trust, dated 6<sup>th</sup> July, 2005, registered as Doc.No.1181 of 2005, in the office of the Sub-Registrar, Anna Nagar, **Shri S.R. ETHIRAJ** has created a Trust, by name of "**Smt. SAKUNTHALA AMMAL CHARITABLE TRUST**" with himself and **Mrs. REVATHI PANNEERSELVAM, P. KRUTHIVAS, P. VISHNUCHARAN** and **K.SANGEETHA**, as first Board of Trustees of the Trust.

**WHEREAS** M.S. Sampath, R.J. Thayumanaswamy, Mrs.T. Vasantha Gowri were appointed as Trustees of the Trust with effect from 2<sup>nd</sup> April, 2012.

**WHEREAS** S.R. Ethiraj, Mrs. Revathi Panneerselvam and K. Sangeetha resigned their Trusteeship from the Trust on 31<sup>st</sup> August, 2012.

**WHEREAS** in order to carry on the activities of the Trust more effectively in the field of education, the Trustees felt the necessity to amend few clauses of the Trust Deed, dated 6<sup>th</sup> July, 2005.

**NOW THIS DEED OF AMENDMENT WITNESSETH:**

1. Clause 1 in Page No.3 of the Trust Deed dated 6<sup>th</sup> July, 2005 reads as follows:


"The Trust shall be known as Smt. SAKUNTHALA AMMAL CHARITABLE TRUST."

**By this Deed of Amendment, the above stated clause is amended as:**

"The Trust shall be known as **Smt. SAKUNTHALA AMMAL EDUCATIONAL TRUST**".

2. Clause 5 in Page No.4 of the Trust Deed dated 6<sup>th</sup> July, 2005 reads as follows:

- (a) To support the poor for their education and to establish, administer and support Schools, Colleges, Polytechnics, Technical Institutions, Research Institutions and other educational institutions.
- (b) To establish and administer Hospitals and Dispensaries for the welfare of the public and to afford medical relief to the sick and suffering irrespective of caste, community or creed.

- (c) To establish and administer Orphanages, Home for aged and the destitute, and Houses for the Blind and Mentally retarded without any distinction as to race, religion or creed.
- (d) To promote the welfare of the poor people without restriction as to caste, community or creed in such manner as may be decided upon the Trustees.
- (e) To work without any motive of profit for the betterment of the under privileged of the society without any distinction for race, religion or creed.

**Since the Trust intends to restrict its activity only in the field of Education, the above stated object clause is amended as follows:**

- (a) To support the poor for their education and to establish, administer and support Schools, Colleges, Polytechnics, Technical Institutions, Research Institutions and other educational institutions.
- (b) To work without any motive of profit for the betterment of the under privileged of the society through education, without any distinction for race, religion or creed.
