
- That the accommodation provided for each of the several divisions is sufficient for the maximum number of members.

- That the latrine arrangements are adequate and satisfactory.
- That the supply of drinking water is wholesome.
- Standard Operating Procedures followed at dining hall.
- Kitchen is maintained neat & Clean.


The Sanitary Certificate is issued subject to the following Conditions:

1. All the Teachers, Students, workers and visitors should be examined by thermal scanning daily.
2. Child labour should not be engaged.
3. Toilet and urinals should be disinfected daily.
4. Drinking water sources should be Chlorinated daily.
5. That the walls should be lime washed with oil paint for 4 feet from the ground level.
6. "No Smoking" sign board, "No Plastic Zone" boards should be displayed size of 3' x 1'in and around the premises.
7. First Aid Box and Sufficient number of Fire Extinguisher & Fire Buckets with water and sand should be provided.
8. Fire Service License should be obtained from Fire Service Department.
9. After Completion of every function effective disinfection and mopping should be done.
10. That the septic tank latrine with sufficient seats (Male/Female) should be constructed and covered with wire mesh over the ventilation pipe.
11. Strictly advise to follow the control measures of COVID - 19 such as wearing Face Mask, Frequent Hand washing, Temperature Screening, surface Disinfection and Maintenance of Social Distance.
12. That the food waste should be removed off from the building premises immediately.
13. That the premises are free from mosquitoes, rats and house flies nuisance.
14. This Sanitary Certificate should be renewed once in a year.
